Whereas the authors of the Trust have originally created a Public Educational and Charitable Trust on 05/06/2002 at Palani, Tamilnadu and registered the same with the Joint Sub Registrar, Palani in No.78/2002 and whereas the present trustees have now deemed it expedient to incorporate certain amendments to the original Deed of Trust and the following amendments are being made with the total consent of all the trustees .

Now this Deed of Amendment witnesseth as under

1. The accounts of the Trust shall be regularly maintained on accepted accounting standards and closed to final accounts on the 31<sup>st</sup> Day of March every year and duly audited by a qualified Chartered Accountant.
2. The surplus funds of the Trust shall be invested in approved funds strictly in accordance with Section 11(5) read with Section 13(1)(d) of the Income Tax Act,1961.
3. The income and funds of the trust will solely be utilized towards the objects of the Trust and no portion of it will be utilized for payment to the trustees by way of profit, dividend, interest etc.
4. The Board of Trustees shall have power to borrow funds, either secured or unsecured, from banks and public financial institutions and others for the purpose of acquisition, development and improvement of movable and immovable assets purely relating to the main objects of the Trust and specifically for carrying on educational activities.
5. The Trust shall not accept/ receive any foreign contribution / donation / aid for the purpose of carrying on the objects of Trust.
6. The benefits of the Trust are open to all irrespective of caste, sex and religion.
7. The objects and activities of the Trust shall be confined to and carried out only in India.
8. In the event of dissolution / winding up of the Trust, the assets remaining as on the date of dissolution shall not under any circumstances be distributed amongst the trustees or members but the same shall be transferred to another charitable trust whose objects are similar to those of this Trust and which enjoys recognition under Section 80G of the Income Tax Act, 1961.






9. Any amendment to the Trust Deed and its bye laws shall be carried out only with the prior approval of the Commissioner of Income - Tax. Any amendment to the Trust Deed shall not extend to alter the basic character / objects of the Trust and further no such amendments shall be repugnant to the provisions of Section 2(15), 11 & 13 and 80G of the Income Tax Act, 1961.

All the other clauses of the original Trust Deed shall be in force and applicable mutatis mutandis.
