- VII. I The teacher performs his duties specified under sub-section(1) of section 24 of the Act and
- VIII. The teacher shall not engage himself for private teaching activities
- IX. The School shall follow the basic requirements and syllabus on the basis of curriculum laid down by Appropriate authority
- X. The School shall maintain the Standards and norms as specified in section 19 of the Act
- XI. No unrecognized classes shall run within the premises of the school or outside in the name of School
